

PAST PERFORMANCES



Health and Human Services -National Institutes of Health -Office of the Director (OD) Office of Financial Management (OFM)

OFM Financial Management, Process Improvement and Technology Support

SG Systems collaborated with experts, stakeholders, and OFM offices to map, analyze, and redesign processes with automation at its core. They developed RPA standards like the Process Design Document (PDD) and Solution Design Document (SDD) and built an attended bot using UiPath Studio for tasks such as data scraping, entry, and decisionmaking, tested with UiPath tools. Ensuring IT compliance, user training, and Authority To Operate, SG Systems deployed the automation via UiPath Orchestrator, reducing Trial Balance and Tie Point Monitoring report time from 120 hours to under 10 minutes—saving NIH 1440 hours annually. During COVID-19, SG Systems enabled email submissions and implemented RPA for invoices, ensuring timely payments without OFM staff in-office. This supported Small Businesses aiding NIH research, maintaining continuity in challenging times.

Systems implemented a modern Acquisition Management System (AMS) that creates a secure business environment and facilitates and supports the cost-effective acquisition of goods and services in support of the mission performance of the Department. The Department's vision is to implement a one-stop, fully integrated, automated, and adaptive full lifecycle acquisition management system that encompasses user-friendly, end-to- end acquisition, business, and financial processes. The system will interface with the Department's financial system (Oracle) and integrate with the Education Central Automated Processing System (EDCAPS). The Department of Education OBSS mitigated its acquisition management successfully challenges through the implementation of SG Systems procurement lifecycle solution. This approach resulted in a swift implementation of a modern, automated, scalable solution, transforming and modernizing the ED acquisition management system.
